

Code of Ethics

Guided by HPCSA

As a registered professional practitioner, Annemarie Jordaan has to act in the interest of all its stakeholders. She, and anyone who is employed or associates with the practice shall at all times behave in such a manner as to demonstrate the values of the profession; and protecting the integrity and branding of the practice.

Competent & Ethical conduct

Provision of information

Annemarie Jordaan shall provide and strive to provide full, fair, accurate and timely financial and other information to guide decision making, to adhere to statutory requirements and to ensure accuracy and transparency in annual reports to shareholders.

Confidential information

Annemarie Jordaan and any associates shall not disclose confidential information concerning the practice, its business, its associates or its clients to any person, entity or competitor unless expressly approved by herself or as required by law. Exceptions to confidentiality may apply in certain circumstances (such as the intent to harm others).

Responsible Citizenship

As responsible corporate citizen of the Republic of South Africa, Annemarie Jordaan and any associates shall respect and uphold the laws of the country and the values enshrined in the Constitution. Upholding and respecting human rights is core to how business is conducted at the practice.

As an entity who serves people, we endeavour to:
